Steps taken to limit the duration and magnitude of vent or flare	Reduced inlet flows to station, cleared out the hydrate in the fuel line, brought compressors back online to stop flaring. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
