Steps taken to limit the duration and magnitude of vent or flare	Inlet flows were reduced to mitigate flaring while mechanics got compressors at CS10 back online. CS11 compressors then brought back online to stop flaring. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
