Hey Tyra,

This one is correct. The calculation is $4089/12/5.61=60.7$ bbl. Please submit a release notification and prepare a c-141. The water was more than 10,000 mg/kg chlorides. There was no death fire or injury. The release has been contained and stopped. Feel free to chat me up in teams if there is any other information you need.

$$4089 \text{ ft}^2 * \frac{1 \text{ ft}}{12} * \frac{1 \text{ bbl}}{5.61 \text{ ft}^3} = 60.7 \text{ bbl}$$
