Once the force majeure event is rectified, these safety functions will no longer be in action as the facility returns to safe and normal operating conditions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	We have established two separate gas purchasing contracts to maximize the takeaway potential of this gas. Each purchaser can carry gas to market, and is not dependent on the other.
