Also compressors at CS10 went down on mechanical issues and caused line pressure to spike and brought more compressors down. Control valves did not react fast enough to control line pressure resulting in flaring
Steps taken to limit the duration and magnitude of vent or flare	Wells shut in to limit flow and line pressure. Standby compressors brought online to stop flaring. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared
