Steps taken to limit the duration and magnitude of vent or flare	Inlet flows were reduced to limit flaring. Operations began to troubleshoot the fuel gas system, fuel scrubber was bled down which seemed to fix the issue. Put the compressors back online. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared
