Please explain reason for why this event was beyond this operator's control	Gas was routed to flare as a result of a compressor valve failure. Targa conducts valve inspections during yearly preventative maintenance (PM) activities and the valves were inspected during the yearly PM in May. Valve temperatures are also monitored weekly.
Steps taken to limit the duration and magnitude of vent or flare	Operations personnel responded immediately to the unexpected shutdown. Maintenance personnel was contacted to replace the valve and chair assembly.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Maintenance personnel replaced the valve and chair assembly as expeditiously as possible. Once replaced, the emission event ended.
