Reason why this event was beyond Operator's control:**

This event was caused by the sudden, unavoidable breakdown of equipment or process that was beyond the owner/operator's control and did not stem from activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and maintenance practices. In this case ETC, third party downstream pipeline operator, shut in their sales gas pipeline to Oxy when potentially contaminated gas was detected and their ESD valve slammed shut. Oxy production techs received malfunction alarms and responded quickly and safely as possible. After all safe and effective purging measures were taken, did Oxy personnel determine the potentially contaminated gas in the sales gas line was the result of unexpected oxygen issues flowing from the gas wells. This event is out of OXY's control. OXY made every effort to control and minimize emissions as much as possible.

2. Steps Taken to limit duration and magnitude of venting or flaring:

It is OXY's policy to route its stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, as the part of the overall process or steps to take to limit duration and magnitude of flaring. Internal OXY procedures ensure that upon notice of flaring, malfunction gas compressor unit and/or multiple unit shutdown alarms, increased sensor line pressure alarms, etc., field production technician personnel are promptly notified, and are instructed to assess the issue as soon as possible to take prompt corrective action and minimize emissions. Oxy production technicians must assess whether the issue or circumstance is due to damage and repair is needed, or whether there are other reasons for its cause. In this case ETC, third party downstream pipeline operator, shut in their sales gas pipeline to Oxy when potentially contaminated gas was detected and their ESD valve slammed shut. Oxy production techs received malfunction alarms and responded quickly and safely as possible. As soon as ETC sales gas line valve closed, Oxy's gas was routed to flare, for a brief duration, as an effective purging measure to remove potential contaminated gas from the sales gas line. While the gas was being purged, Oxy field and control room personnel began adjusting well optimizer injection gas rates and choking back several high GOR wells, until gas pressure stayed below the flare trigger setpoints of the facility to cease flaring. Once Oxy's gas sales lines system was purged of the potentially contaminated gas, did Oxy personnel contact ETC personnel to reopen their sales gas pipeline valve so they could begin taking gas again. This event is out of OXY's control. OXY made every effort to control and minimize emissions as much as possible.

3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:

Oxy is limited in the corrective actions to eliminate the cause and potential reoccurrence of an ETC gas flow pipeline restriction or shut-in, as this control issue is downstream of Oxy's custody transfer point and out of Oxy's control to avoid, prevent from happening or reoccurring. OXY makes every effort to control and minimize emissions as much as possible. The only actions that Oxy can take and handle that is within its control, is to continually communicate with ETC personnel during these types of situations and conduct all available safe and effective measures to rectify sudden and unexpected potential gas contamination, that is beyond Oxy's control to predict, foresee or avoid.
