LOGOS conducted an elective flyover on July 5th, 2024, during the flyover a plume was identified near the Rosa Unit 372. The results were received from the vendor on July 8th, 2024. In response LOGOS sent out an OGI camera to detect any leaks. An underground pipeline leak was identified on July 9th, 2024, and was isolated. Due to the current wellbore state and recent wellbore non-productive period estimated lost gas is based off a flowline hole engineering estimate.
