**Venting because of a piping leak on the compressor**

**Facility: 30-045-28250**

**During an elective flyover, on July 5<sup>th</sup>, 2024, a plume was identified at Blanco 330. Operations identified a leak on the compressor cooler piping, on July 8<sup>th</sup>, 2024, and isolated the leak in response to the notification. Follow-up OGI detected no additional leaks on-site, on July 9<sup>th</sup>, 2024. The most recent AVO prior to the flyover was on July 2<sup>nd</sup>, 2024. Based on a production differential is it estimated that the leak began on the last AVO date.**
