Venting due to a downhole failure
Facility: 30-039-24390

During an elective flyover, on July 5th, 2024, a plume was identified at Rosa Unit 200. Operations identified no fluid production and gas being pumped to the tank due to the downhole failure. The surface unit was shut down and a downhole failure has been confirmed. Follow-up OGI detected no additional leaks on-site, on July 8th, 2024. The most recent AVO prior to the flyover was on July 2nd, 2024. Based on a production differential it is estimated that the leak began on the last AVO date.
