**1. Reason why this event was beyond Operator's control:**

This emissions event was caused by the unforeseen, unexpected, sudden, and unavoidable breakdown of equipment or process that was beyond the owner/operator's control and did not stem from activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and preventative maintenance practices. Oxy engages in respectable and good facility operation practices while also maintaining its continuous facility equipment preventative maintenance program. In this case, there was a sudden and unexpected automated malfunction with the VRU PLC that controls VRU units 1-5, which had a communication failure, which then prompted a sudden automatic shutdown of those units. A flaring event was triggered when the VRU's shutdown automatically as there is no prior warning of any kind for this type of equipment failure. This event is out of OXY's control yet OXY made every effort to control and minimize emissions as much as possible.

**2. Steps Taken to limit duration and magnitude of venting or flaring:**

It is OXY's policy to route its stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, that is beyond Oxy's control to avoid, prevent or foresee, to minimize emissions as much as possible as part of the overall steps taken to limit duration and magnitude of flaring. The flare at this facility has a 98% combustion efficiency to lessen emissions as much as possible. In this case, there was a sudden and unexpected automated malfunction with the VRU PLC that controls VRU units 1-5, which had a communication failure, which then prompted a sudden automatic shutdown of those units. A flaring event was triggered when the VRU's shutdown automatically as there is no prior warning of any kind for this type of equipment failure. As soon as flaring occurred, the facility's well optimizer adjusted injection rates, which prompted flaring to cease a short time later. Automation personnel were called to be dispatched. Once automation was able to arrive at the facility, they were able to repair the PLC communication failure. Notwithstanding proper VRU design and operation, various forms of mechanical, automated, or technical issues can be sudden, reasonably unforeseeable, and unexpected which can cause VRU unit malfunctions to occur without warning or advance notice. VRU's are designed to operate in a precise manner and when malfunctions occur, it disrupts the VRU unit's operating manner causing an automatic shutdown of the unit. This event is out of OXY's control yet OXY made every effort to control and minimize emissions as much as possible.

**3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:**

Oxy is limited in the corrective actions available to them to eliminate the cause and potential reoccurrence of VRU malfunctions as notwithstanding VRU design and operation, VRU's are inherently dynamic and even the smallest alarms, false or true, can be sudden, reasonably unforeseeable and unexpected which can cause VRU malfunctions to occur, thereby, triggering the unit to automatically shut down. Oxy continually strives to maintain and operate all its equipment in a manner consistent with good practices for minimizing emissions and reducing the number of emission events. Oxy has a strong and positive equipment preventative maintenance program in place.
