Please explain reason for why this event was beyond this operator's control	Gas was routed to flare as a result of high discharge pressure. This discharge pressure was caused by a failed liner in a steel pipeline. During scheduled maintenance activities, running a pipeline pig, it was discovered that the liner in a steel pipeline failed, resulting in the compressor going down on high discharge pressure.
Steps taken to limit the duration and magnitude of vent or flare	Operations personnel responded immediately to the high discharge pressure and re-routed gas to accommodate pipeline repair safely.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Operations personnel have re-routed gas to accommodate safe pipeline repairs and notified producers. The pipeline will be repaired and once deemed safe to operate, returned to service.
