

Describe Cause of Problem and Remedial Action Taken.*

A seal on the transfer pump failed and was repaired. Fluids were released to the lined tank battery. It was originally believed the release had an overspray onto the pad, but after communications with field personnel, and multiple onsite investigations, it has been determined that the entire release was contained within the impermeable lined tank battery.

Describe Area Affected and Cleanup Action Taken.*

All fluids were removed by vacuum truck and tanks and liner were pressure washed. Liner integrity inspection performed by third party and the liner was found to be impervious.
