Please explain reason for why this event was beyond this operator's control	initially lost compressors due to false tank levels caused by freezing conditions. After restarting compressors, compressors were going down on high discharge pressure which was found to be caused by a hydrate in the sales line.
Steps taken to limit the duration and magnitude of vent or flare	Cut back on production to mitigate flaring. Cleared hydrate in sales line and restarted compressors. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared
