Pressure transmitter causing back pressure valve to stay open which caused compressor to go down on low 3rd stage discharge, and subsequently 2 others to go down on high 1st stage suction scrubber pressure.
Steps taken to limit the duration and magnitude of vent or flare	Production was curtailed to mitigate flaring. Bled down transmitter resulting in correct pressure reading. Reset and started the compressors. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared
