Please explain reason for why this event was beyond this operator's control	Silverback could not have anticipated the current event which was caused by high pressure in DCP's pipeline. DCP has a back pressure valve installed on their sales meter run that closes and diverts our gas to flare when their pressure increases above a set amount.
Steps taken to limit the duration and magnitude of vent or flare	We documented the incident in order to send a notification to DCP to resolve the high line pressure issue.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	In order to eliminate the flare event, DCP needs to install more compression so back up compression is available.
