The VRUs rely on the pressure sensor/transmitter to cycle on and off. Since the transmitter failed, the VRUs did not function as designed when the tank pressure increased. This caused intermittent venting from tanks during the time the sensor was malfunctioning.                     |
| Steps taken to limit the duration and magnitude of vent or flare                                                                 | Upon discovery of venting the sensor was immediately repaired, the VRUs came back to normal operation and the venting ceased. All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions. |
