Are there additional details for the questions above (i.e. any answer containing Other, Specify, Unknown, and/or Fire, or any negative lost amounts)	We had a reportable release at the Royal Oak 25 Federal Com 9H during frac operations. Shortly after initiating treatment #31, we observed a pressure drop at 6:00 AM while pumping at 85 bpm. A thorough inspection of the well and lines revealed no visible issues. However, at 6:50 AM, the pressure unexpectedly increased, and produced water was seen spilling from the top of the flowback tank. Operations were temporarily suspended, and valves were inspected before we resumed work. Upon further investigation, we discovered that a valve had been inadvertently opened, redirecting produced water meant for frac operations into the flowback tanks. This diversion caused the flowback tanks to fill and overflow into the secondary containment area. Subsequently, the secondary containment also filled to capacity and overflowed onto the well pad. We will schedule an assessment and remediation for the impacted areas in the coming weeks, following the completion of frac operations.
