Spur Energy Partners (Spur) has contracted Pima Environmental Services, LLC (Pima) to perform a liner inspection and prepare this closure report for the release of produced water that happened on the State S-19 TB (State). An initial release was discovered on September 25, 2025. This incident was assigned Incident ID nAPP2526942456, by the New Mexico Oil Conservation Division (NMOCD).

Site Information and Site Characterization

The State is located approximately 7.70 miles west of Loco Hills, NM. This spill site is in Unit J, Section 19, Township 17S, Range 29E, Latitude 32.81721 Longitude -104.11267, Eddy County, NM. A Location Map can be found in Figure 1.

Based on well water data from the New Mexico Office of the State Engineer, there are no known water wells located within a half-mile radius of the site. Conversely, as per the United States Geological Survey well water data, the nearest groundwater depth in this region is recorded at 78.5 feet BGS, situated approximately 2.68 miles away from the State. For detailed references to water surveys and the precise locations of water wells, please refer to Appendix A, inclusive of the relevant maps. Notably, the State is situated within an area with a low potential for karst, as illustrated in Figure 3. Additionally, a comprehensive Topographic Map is available for reference in Figure 2.

Release Information

nAPP2526942456: On September 25, 2025, a transfer pump failed to start, causing the storage tank to release approximately 31 barrels of produced water into the lined containment. Spur personnel immediately initiated recovery efforts and successfully recovered all 31 barrels using a vacuum truck. No impacts occurred outside of the lined containment. A Site Map can be found in Figure 4.

Site Assessment and Liner Inspection

On October 13, 2025, Spur personnel submitted a notification for a liner inspection, adhering to the necessary 48-hour notice period. The details of the 48-hour notification can be referenced in Appendix C.

On October 16, 2025, Pima Environmental conducted a thorough inspection of the lined containment area. The evaluation process included cleaning the liner with a power washer and using a vacuum truck to ensure the complete removal of any residual fluids. The inspection confirmed that the system remained intact and successfully retained all fluids. As a result, the liner was deemed functional, preventing any further environmental impact. A detailed report, including photographic evidence, is provided in Appendices C and D.

Closure Request

After careful review, Pima requests that this incident nAPP2526942456 be closed. Spur has complied with the applicable closure requirements.








