During an elective flyover on February 4, 2026, a plume was identified at Rosa Unit 267A. Operations identified a dump valve malfunction, and the issue was repaired immediately upon discovery on February 5, 2026. Follow-up OGI performed on February 6, 2026, confirmed no additional leaks on site.
