The leak was isolated and contained. It is estimated that approximately 60 BBLs of an oil/water mixture was released to soil. All free standing liquid was removed via vacuum truck and sent for reprocessing through the Refinery's onsite Wastewater Treatment Unit. Contaminated soil was removed and containerized, and will be characterized for off-site disposal. There was no off-site impact.
