Upon investigation it was determined that the fire eye on #1 TLA had caused ESD. Techs checked for source and found bonnet for #5-cylinder head had a small crack near gas valve. The fire eye detected a small flame that extinguished itself. No injuries, no liquids released, no emergency services responded, and no impact to the public.</b>
