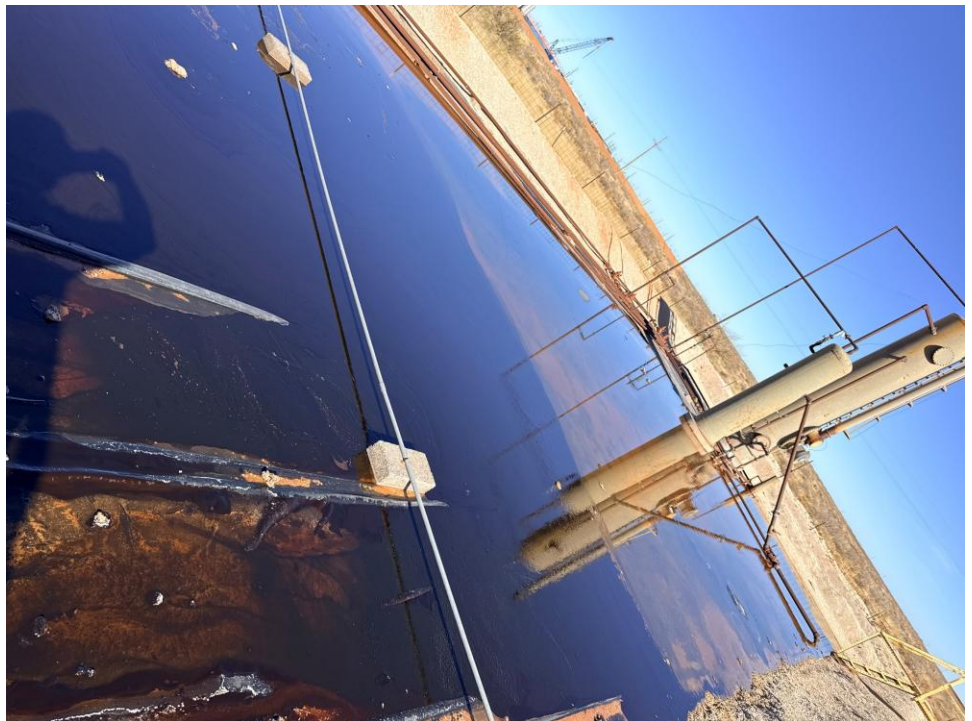

The water transfer pump tripped and failed to reset, which caused the produced water tank to overflow into the lined containment. This incident resulted in the release of 15 barrels of produced water into the lined containment. All fluids remained inside the containment and were recovered with a vac truck. The containment will be washed, and a liner inspection will be scheduled in the coming days.
