Good afternoon. Thank you once again for taking the time to talk with us yesterday afternoon regarding the need to clean up some of the OGRID numbers and associated incidents/facilities.

I have completed the Facilities Transfer Form (spreadsheet) for the facilities in question. There are three tabs on the spreadsheet associated with the three entities that we are working to associate the facilities with. They would be:

- (329750) Transwestern Pipeline Company, LLC
- (371183) ET Gathering & Processing LLC
- (237722) ETP Crude LLC

We completed a separate transfer form for each of the entities. Hopefully I filled those out correctly and had Stacy Boultinghouse (Environmental Manager responsible for remediation projects) sign them. Please review and let me know if there are any questions or concerns on the forms.

Additionally, I did include that spreadsheet that we reviewed in the meeting. That is just a sheet I put together for our use to cross reference information in the OCD's ePermitting database.

Column A lists the Incident ID for our open remediation projects. Column B shows the OGRID of the entity currently listed as the operator for the incident in the database. Column C lists the OGRID of the entity that should be listed as the operator.

Likewise, Column G lists the facility ID for the facility tied to the incident. Column I shows the entity currently listed as the operator, and column J lists the entity that should be listed as the operator.

Good afternoon. Thank you again for taking the time to discuss the issues we're having with inactive/outdated OGRID numbers associated with ongoing remediation work.

Over the years several OGRIDs have been created for operating entities and the open projects were not officially moved over to the most recent Operator.
