The currently-identified affected wells are: • LU-LU #002 (API No. 30-043-20655) • LU-LU #003 (API No. 30-043-20675) • LU-LU #005 (API No. 30-043-20680) At this time, each release is estimated to have exceeded 100 barrels (±) of stimulation fluid. The LU-LU #005 release migrated off the well pad location. The releases associated with LU-LU #002 and LU-LU #003 has currently remained contained on location. LOGOS personnel responded immediately upon notification, are actively assessing the extent of the impacts and are assessing and implementing appropriate response and remediation measures. LOGOS believes that it has currently contained all released fluids and has taken measures to prevent further migration of released fluids. Additional details will be provided as they become available. LOGOS will

submit a separate Form C-141 for each affected well, along with the required Notice to Launch (NTL) documentation. Please let me know if you have any questions or require additional information
