1. Set RBP in 5 1/2" casing at 1,700'.
2. Set Whip stock in 5 1/2" casing at 1,674'.
3. Cut window in 5 1/2" casing at 1,668' - 74'.
4. Drill a 4 3/4" hole in a 131' (42°) Radius curve to a 1,921' horizontal lateral in the upper Vermejo coal (Top 1,805').
5. Run 3 1/2" liner (No Cement) the length of the lateral.
6. Retrieve Whip stock and RBP.
7. Clean out well bore, run production equipment, and put well back on production.
