02/13/05 Spud @ 9:30 a.m.. Drill 11" surface hole to 347'. Run 8 jts. of 8 5/8", 24#, J55 ST&C casing to 337'. Halliburton mixed and pumped 100 sx Midcon II, 14 ppg, yield 1.66. Circulate 3 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

02/14/05 Drill 7 7/8" hole from 347' - 1,295'. Reached TD 1,295' at 4:00 p.m. MIRU Patterson and log well. Logger's TD at 1,032'. Ran 30 jts of 5 1/2", 15.5#, J55 LT&C casing to 1,258'. MIRU Halliburton. Pumped water and gel spacer at 4 bpm, with 80 psi. Pumped 172 sks Midcon II at 13 ppg, 2.04 yield. Bumped plug with 1286 psi. Circulated 12 bbls of cement to surface. Well shut in.
