MUD PROGRAM: 0-400' FW Gel; 400'-1000' Fresh Water; 1000'-7050' Cut Brine; 7050'-7900' Salt Gel/Starch/4%-6% KCL. BOPE PROGRAM: A 5000# BOPE will be installed on the 9 5/8" casing and tested daily.
