Test 13 5/8" casing to 1000 psi, hold 30 minutes. 7. Drill 11" hole to 3100' md / tvd 8. Run and cement 8 5/8" intermediate casing to surface 9. Land 8 5/8" casing in MBS wellhead. 10. Test 8 5/8" casin
