Schlumberger crnt'd w/ 150 sx RFC w/ 3 pps D24 & 0.125 pps D130 (14.2 ppg, 1.6 yield), 415 sx "C" w/ 0.125 pps D130 & 2% CaCl (14.8 ppg, 1.34 yield) and 150 sx "C" w/ 2% CaCl (14.8 ppg, 1.32 yield). Had good circ during job & bumped plug w/ 500 psi at 11:59 PM 4/7/06. Floats held OK, circ 200 sx to surface. Installed WH & BOPE, and tested csg & BOP to 500 psi after 22 1/2 hrs WOC.
