Casing/Cement Program: Additional Comments

COG proposes to drill a 17 1/2 hole to 425, run 13 3/8 casing and cement. Drill a 12 1/4 hole to 1225, run 8 5/8 casing and cement. Drill a 7 7/8 hole to 6000 test paddock formation, run 5 1/2 casing and cement. Note: On production string a fluid caliper will be run and will figure cement with 25% excess, attempt to circulate.

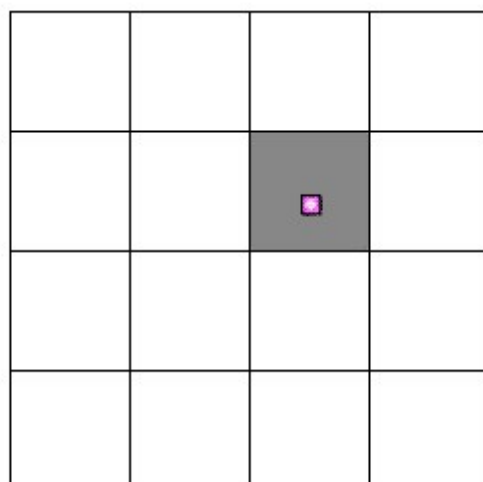
