6/8/06 Set 8-5/8" 24# J-55 casing at 1110'. Cemented with 100 sx RFC with additives (yld 1.62, wt 14.2) and 500 sx 35-65-6 Poz "C" (yld 1.99, wt 12.6). Tailed in with 200 sx Class "C" (yld 1.32, wt 14.8). Cement did not circulate. Ran temperature survey - TOC at 930'. Ran 1" cement to surface with 869 sx Class "C" cement. Tested casing to 1000 psi for 30 min. Reduced hole to 7-7/8" and resumed drilling 9/30/2005 Spudded well.
