Mack Energy proposes to drill a 17 1/2 hole to 450', run 13 3/8 casing and cement. Drill a 12 1/4 hole to 1400', run 9 5/8 casing and cement. Drill a 8 3/4 hole to +-4900', kick off a 7 7/8 horizontal hole appr. 3950' north, run 5 1/2 casing and cement. Note: On production string a fluid caliper will be run and will figure cement with 25% excess, attempt to circ.

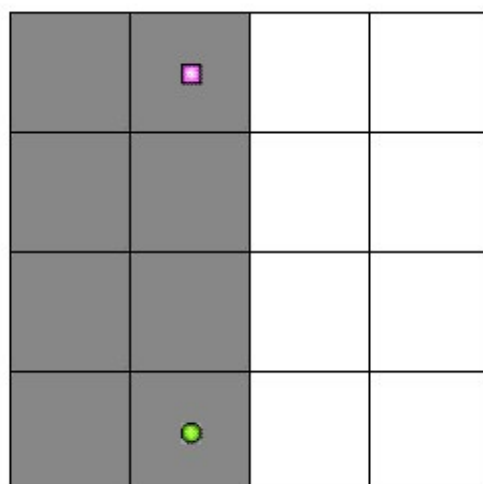
