Drill a 7 7/8 hole to 12,500', run 5 1/2 casing and cement. Note; On production string a fluid caliper will be run and will figure cement with 25% excess, attempt to circulate.

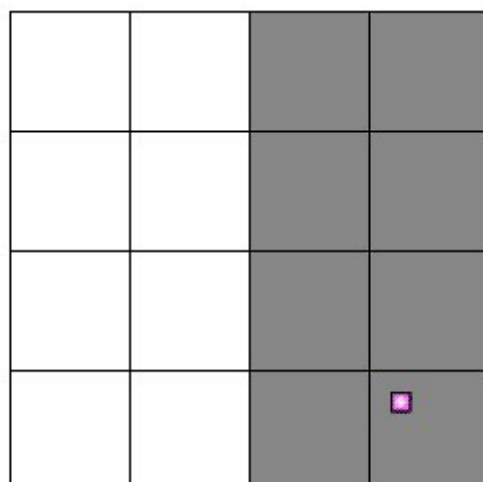
