**Casing/Cement Program: Additional Comments**

COG proposes to drill a 17 1/2 hole to 300' set 13 3/8 casing and cement to surface. Drill a 12 1/4 hole to 850' set 8 5/8 casing and cement. Drill a 7 7/8 hole to 5500 test Blinebry formation, run 5 1/2 casing and cement to surface. Note: On production string a fluid caliper will be run and will figure cement with 25% excess attempt to circ.
