COG proposes to drill 17-1/2 hole to 300 w/fresh water mud system, wt 8.5, vis 28 & set 13-3/8 csg & cmt to surf. Drill 12-1/4 to 850 w/brine mud system, wt 10, vis 30. Set 8-5/8 csg & cmt to surf. Drill 7-7/8 hole to 5600 w/cut brine mud system, wt 9.1, vis 29-32. Test Yeso formation. Run 5-1/2 csg & cmt to surf. Note: On production string, a caliper will be run, & COG will attempt to cement to surface.

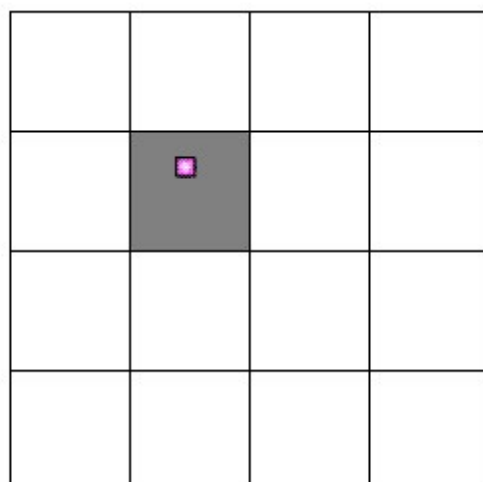
