COG proposes to drill 17-1/2" hole to 350' w/fr water mud system, wt 8.5, vis 28 & set 13-3/8" csg & cmt to surf. Dr 12-1/4" to 1800' w/brine mud system, wt 10, vis 30. Set 8-5/8" csg & cmt to surf. Dr 7-7/8" hole to 6700' w/cut brine mud system, wt 9.1, vis 29-32. Test Yeso formation. Run 5-1/2" csg & cmt to surf. Note: On production string, a caliper will be run, & COG will attempt to cement to surface.

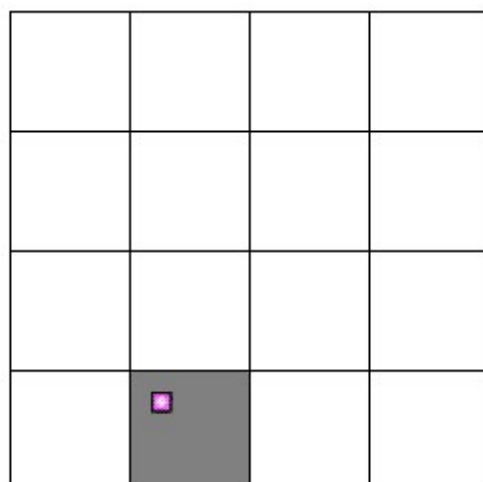
