COG proposes to drill a 12-1/4" hole to 350' w/fr wtr mud system, wt 8.5, vis 28, set 8-5/8" casing & cement to surface. Drill a 7-7/8" hole to 5450' w/fr mud system, wt 10, vis 30. Test Yeso formation. Run 5-1/2" casing & cement to surface. Note: On production string, a caliper will be run, COG will attempt to circulate cement.

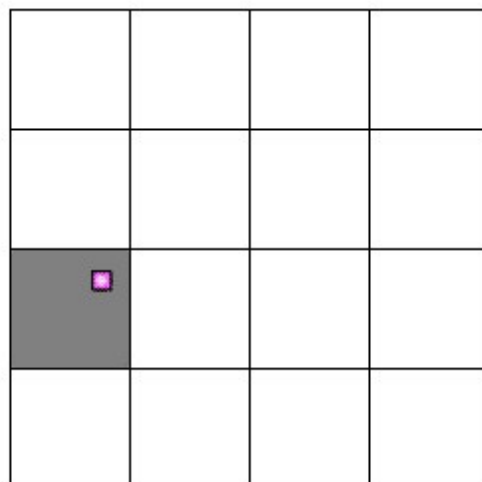
