Casing/Cement Program: Additional Comments

COG proposes to drill a 17-1/2 hole to 650' w/fr water mud system, wt 8.5, vis 28, set 13-3/8" casing & cement to surface. Drill an 11" hole to 2100' w/fr mud system, wt 10, vis 30, set 8-5/8" casing & cement to surface. Drill a 7-7/8" hole to 7000' w/cut brine mud system, wt 9.1, vis 29-32. Test Yeso formation. Run 5-1/2" casing & cement to surface. Note: On production string, a caliper will be run, COG will attempt to circulate.

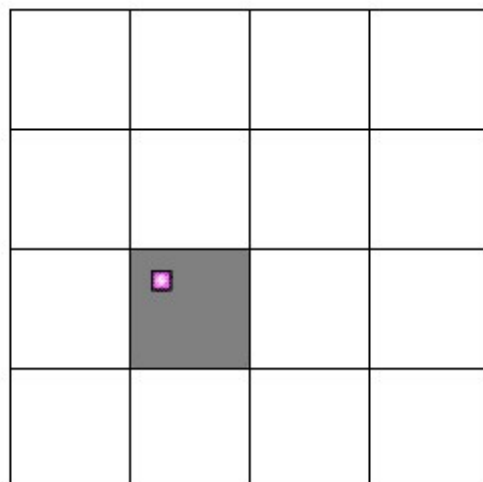
