Set 8-5/8" casing & cement to surface. Drill 7-7/8" hole to 5500' w/cut brine mud system, wt 9.1, vis 29-32. Test Yeso formation. Run 5-1/2" casing & cement to surface. Note: On production string, a caliper will be run, COG will attempt to circulate cement.


