Casing/Cement Program: Additional Comments

COG proposes to drill a 17 1/2" hole to 350' with a 8.5 ppg, 28 viscosity fresh water mud system. Set 13 3/8" casing and cement to surface. Drill a 12 1/4" hole to 1350' with a 10 ppg, 30 viscosity brine water mud system. Set 9 5/8" casing and cement to surface. Drill an 8 1/4" hole to 3823' MD and kick off and drill an 8 1/4" curve to 4581' MD. Drill a 7 7/8" lateral to new BHL at 4228' TVD 8752' MD. Run a tapered string with 7" 26# L-80 from surface to 3823' & 5 1/2" 17# L-80 casing to TD with DV/ECP Combo Tool at 3823' and isolation packers in the open hole. Set isolation packers and ECP. Open DV tool and cement from 3823' to surface.

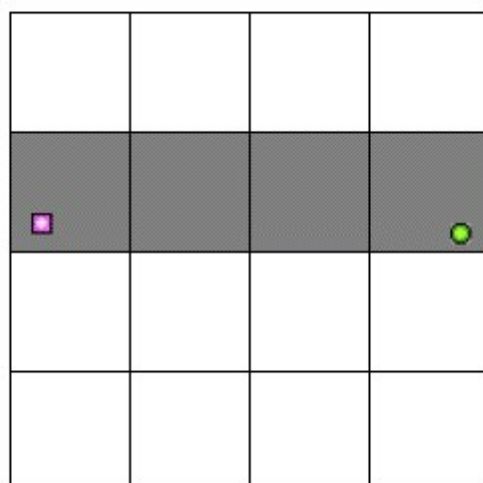
