COG proposes to drill an 11" hole to 1200' w/fresh water, run 8 5/8" 32# J-55 and cement to surface. Drill a 7 7/8" hole to 3160' MD and kick off and drill curve to 3679' TVD 4199' MD. Drill a 7 7/8" lateral to new BHL @ 3641' TVD 8538' MD. Run a 5 1/2" 17# L-80 casing to TD cement to surface with 800 sacks.
