Casing/Cement Program: Additional Comments

Plan to drill a 17-1/2" hole to 400' with Fresh Water into the Rustler to cover FW water depth. Run 13-3/8", 54.5# J-55 casing and cement to surface. On 13-3/8" Surface Casing, Install 3000 psi casing head, NU 13-5/8" Cameron BOP. Test annular and casing to 1500 psi and other BOP equipment to 3000 psi. Drill 12-1/4" hole to 2330' with 10# Brine, and run 9-5/8", 2330' of 40# J55 STC and cement to surface in one stage. On 9-5/8" Intermediate Casing, Install 5000 psi casing spool, NU 13-5/8" Cameron BOP. Test casing to 1500 psi. Test annular to 1500 psi and other BOP equipment to 3000 psi. Drill an 8-1/2" vertical, curve and lateral with cut Brine to approximately 17,810' MD. Run 5-1/2" 17# P110 casing to TD and cement in one stage bringing cement up to 1500' in one stage.
