Run 9-5/8" 40# J55 BTC to TD and cement to surface in 1 stage. Drill 8-3/4" vertical, curve & lateral to TD with cut brine water. Run 5.5" 17# P110 BTC casing to TD and cement to 500' tie back into intermeidate casing.
