Drill 17-1/2" hole to ~1,850' w/ fresh water spud mud. Run 13-3/8" 54.5# J-55 BTC casing to TD and cement to surface in one stage. Drill 12-1/4" hole to ~5,650' with saturated brine. Run 9-5/8 40# J-55 BTC to 3500' and 9-5/8 40# L-80 BTC casing from 3500' to TD and cement to surface in two stages with DV/ECP 100' above reef. Drill 8-3/4" vertical hole, curve & lateral to 16,242' with cut brine. Run 5-1/2" 17# HCP110 BTC casing from TD to surface and cement to surface in one stage.

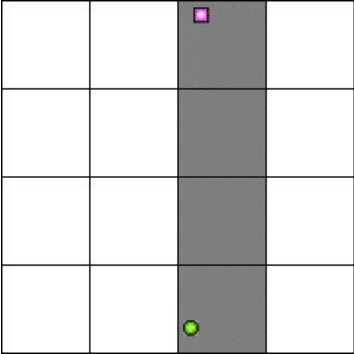
