
JOB PROCEDURES

1. Notify BLM / NMOCD at least 48 hours prior to conducting the MIT.
2. Record current wellhead pressures, ND existing piping on casing valve
3. RU pump truck, pressure test surface equipment and wellhead to 1000 psi
4. Load well and pressure test CICR at 3569' to 650 psi, hold for 30 minutes and chart on a 2 hour chart. Monitor tbg and surface csg pressures
5. Bleed off pressure, break out surface piping and RD pump truck. NU existing piping.
