12/14/2020: Run 9.625 inch 40 lb J55 intermediate casing to 5285 ft. Pump 20 bbls chem wash, 20 bbls vis water, followed by 1162 sks of 13.5 ppg lead cmt, 446 sks of 14.8 tail cmt. Drop plug and displace with 397 bbls of freshwater. 80 bbls of cement returned to surface. Pressure test casing to 1500 psi for 30 minutes, good test.

Intermediate Casing Details: Casing ran: 12/14/2020, Fluid Type Brine, Hole 12.25 inch, Csg Size 9.625 inch, Weight 40 lbs, Grade J55, Est TOC 0 ft, Depth set 5285 ft, Cement 1608 sacks, Yield 1.33, Class C, Pressure Held 1500 psi, Pres Drop 0.
