Actual Procedure: 1/17/2021: Drill 12.25 inch first intermediate hole to 5305 ft. 1/18/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5290 ft. Pump 20 bbls chem water, 20 bbls gel spacer, followed by 1182 sks of 13.5 ppg lead cmt, 414 sks of 14.8 ppg tail cmt. Drop plug and displace with 398 bbls of freshwater. 120 bbls of cement back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 1/19/2021: Drill 8.75 inch second intermediate hole to 11700 ft. 1/23/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11595 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 455 sks of 11.5 lead cmt, 143 sks of 13.2 ppg tail cmt. Drop plug and displace with 530 bbls of freshwater. 0 bbls of spacer returned to surface. Est TOC at 4000 ft. Pressure test casing to 2650 for 30 minutes, good test.
