**Actual Procedure:** Well Spud on 1/30/2021 at 18:45. 1/30/2021: Drill 17.5 inch surface hole to 1050 ft. Run 13.375 inch 54.5 lb J55 surface casing to 1042 ft. Pump 40 bbls gel spacer, followed by 605 sks of 13.5 ppg lead cmt, 550 sks of 14.8 ppg tail cmt. Drop plug and displace with 154 bbls of brine water. 200 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 2/1/2021: Drill 12.25 inch first intermediate hole to 5294 ft. 2/2/2021: Run 9.625 inch 40 lb J55 first intermediate casing to 5283 ft. Pump 20 bbls chem water, 20 bbls gel spacer, followed by 1182 sks of 13.5 ppg lead cmt, 414 sks of 14.8 ppg tail cmt. Drop plug and displace with 400 bbls of freshwater. 2 bbls of cement returned back to surface. Pressure test casing to 1500 PSI for 30 minutes, good test. 2/3/2021: Drill 8.75 inch second intermediate hole to 11395 ft. 2/6/2021: Run 7.625 inch 29.7 lb P-110 second intermediate casing to 11381 ft. Pump 20 bbls chem wash, 20 bbls visc water, followed by 442 sks of 11.5 lead cmt, 138 sks of 13.2 ppg tail cmt. Drop plug and displace with 521 bbls of cut brine. small amounts of spacer returned to surface. Est TOC at 2966 ft. Pressure test casing to 2500 for 30 minutes, good test.
